Public Health Nutritionist Position at ODH

The Ohio Department of Health (ODH) is seeking a Registered and Licensed Dietitian to serve as the **Title V Maternal and Child Health Block Grant Breastfeeding Coordinator**. Under the direction of the WIC Nutrition and Administrative Services Supervisor, this position will plan and implement statewide breastfeeding programs and initiatives with hospitals, worksites, and child care facilities. The Breastfeeding Coordinator will also collaborate with internal and external partners to develop, revise, and implement goals and objectives to address breastfeeding in the State of Ohio.
