Executive Director's Note

One of the greatest privileges I have as Executive Director of the Charitable Healthcare Network (CHN) is the opportunity to regularly travel around Ohio and meet the leaders, volunteers, and providers who power our state's free and charitable clinics. Every visit reaffirms that our network is made up of dedicated, passionate individuals committed to delivering high-quality, patient-centered care to those who need it most.

Just as the communities we serve have their own distinct identities, each clinic in our network is unique, yet all are united by a shared mission to provide compassionate, high-quality healthcare to Ohioans who might otherwise go without it. Your commitment to this mission makes our work possible, and I am deeply grateful for the many ways you help expand access to care.

In 2024, we took a significant step in sharpening our focus by refining CHN's mission statement to more directly emphasize our role in strengthening and ensuring high-quality healthcare for Ohio's most vulnerable populations. Every day, with and through the free clinics and charitable providers in our network, we work to turn that mission into reality.

Our network has long focused on delivering exceptional care, and we also recognize the importance of sharing our story of resilience, impact and unwavering service with those who are not familiar with our work. Since 2022, CHN clinics have increased the number of healthcare services provided by more than 200,000. In 2024 alone, our network delivered more than 715,000 healthcare services, valued at nearly \$225 million, at little to no cost to the patient. That represents a \$25 million increase in care provided in just the past two years. By amplifying our message, we can ensure more Ohioans understand the critical role free and charitable clinics play in our healthcare system.

A transformational gift from the estate of Warren H. Wefler continues to help us tell the powerful story of our impact. Thanks to his generosity, CHN has launched a strategic public awareness campaign to ensure that more Ohioans recognize the essential role free clinics and charitable providers play in our healthcare system. In 2024, we completed phase one of this effort in partnership with Geben Communication, and we look forward to working directly with clinics in 2025 to further amplify their stories.

In addition to the generosity of the Wefler estate, none of this would be possible without the partnership of the Ohio General Assembly, the Ohio Department of Health, and the DeWine Administration, and we remain incredibly thankful for their support and inclusion of Free Clinic Safety-Net funding in the state's biennial budget. We also thank the Cardinal Health Foundation for supporting our work to redefine medication access through the innovative Equity Rx initiative.

Through these partnerships, Ohio's free and charitable clinics continue to make our state a healthier, stronger place for all.







ACA Health Insurance Navigator Program



Ohio Counties Covered

In September 2024, CHN signed a five-year, renewed contract with the Ohio Association of Foodbanks to receive pass-through funding from the federal Centers for Medicare & Medicaid Services for Insurance Navigators to be placed throughout the state. Navigators are federally certified and licensed by the State of Ohio to provide free and unbiased help enrolling in Medicaid and Marketplace health insurance. Regardless of where they are located, each Navigator is dedicated to helping enroll as many consumers as they can in health insurance. In 2024, our Navigators saw nearly **7,700** consumers serving 23 counties across the state of Ohio, resulting in **1,103** people enrolling in coverage.

Cardinal Health Equity Rx

With generous support and partnership from the Cardinal Health Foundation, CHN developed a two-pronged approach in 2024 to ease one of the biggest issues for patients served by free clinics and charitable providers: consistent access to affordable and/or free medications.

The first part of the two-year, \$500,000 grant, sought to take a short-term support approach by offering \$1,000 for free clinics and charitable providers to help care for patients in medication crisis. This funding helped support the immediate need of our network by supporting the gaps in care quickly.

Simultaneously, CHN partnered with St. Vincent de Paul Charitable Pharmacy (SVDP) to develop an extensive approach to easing barriers to medication access for vulnerable patients. SVDP became the pharmacy of record for three clinics (Good Samaritan Free Heath Center in Cincinnati, Reach Out Montgomery County, and Good Neighbor House, both in Dayton) in the first year of the grant, serving as a medication distribution vehicle but more importantly, inserting a pharmacist into the care team of these clinics to support patient education, medication adherence and, overall, to improve the care for these patients.

As a result of this partnership, CHN is working towards the goal of doing more than just providing medication procurement and delivery but supporting the short-term needs of clinics while building towards a long-term goal of improved patient care.


